## G.C.E. (O.L.) Examination –2025(2026)

It is hereby notified that the G.C.E. (O.L.) Examination is scheduled to be held from 17<sup>th</sup> February to 26<sup>th</sup> February 2026.

Admission cards of school candidates of this examination have been already posted to the heads of respective schools and to the addresses of private candidates as provided in their applications. It is hereby notified that the admission cards sent to the heads of schools **should be handed over to relevant candidates immediately** and should not be delayed for any reason.

Admission cards can be downloaded through the official website [www.doenets.lk](http://www.doenets.lk) from 05.02.2026 for private candidates who have not yet received admission cards by post.

Any private applicant who has not received admission card or could not download yet should visit the Department of Examinations with a photocopy of the application, a photocopy of the receipt for payment of examination fee or a certified letter obtained from the Post Master confirming the payments of examination fee.

**Any changes to be made in the subject, medium or name cited in the admission cards received by Principals or private candidates,**

- Should be amended online accessing the website <http://onlineexams.gov.lk/eic>.
- Only one attempt of revision will be given to each candidate.
- Examination centres in this examination will not be changed.
- The duration offered for changes will be concluded at 12.00 midnight on 10.02.2026.

The National Identity Card issued by the Department of Registration of Persons, a valid Passport or a valid Driving License will be accepted as a valid document to prove identity of a candidate at this examination.

01. Appearing of any other person for a candidate at the examination, keeping notes in possession while answering, getting assistance from or assisting another candidate fraudulently, or misbehaving in and around the examination hall shall be a punishable offence under the Examinations Act.
02. Using calculators and correcting fluid in this examination is not permitted.
03. Sitting for this examination as a private candidate while studying in a government school shall be a punishable offence.
04. Bringing Mobile Phones, Smart Watches or Electronic Devices into the examination hall, keeping in possession and using such devices is strictly prohibited. Any candidate who violates this condition will be penalized under Public Examinations Act No.25 of 1968.
05. In order to be affirmed that the candidates are not using Bluetooth or any other electronic communication device, that the all candidates should keep their faces and ears opened as to clearly visible during the examination. Action will be taken according to the law against the candidates who are not following these instructions.
