MINIMUM REQUIREMENTS FOR ADMISSIONS

Candidates who have satisfied the minimum requirements at the G.C.E. (A/L) Examination held in 2025 for the University Admissions (Refer the UGC Hand Book 2025/2026) and possess at least a credit pass (C) in the selected subject and a simple pass (S) in the other two subjects.

MEDIUM OF THE APTITUDE/ PRACTICAL EXAMINATION

The Aptitude/ Practical Examination will be conducted only in the Tamil Medium. (Refer the UGC Hand Book 2025/2026)

SUBMISSION OF APPLICATIONS

Applicants should fill and submit the application form appended below through online. Further, applicants should send all the scanned documents mentioned in Section - 6 of application form through online **on or before 13.05.2026** along with duly filled online application form (**Link: <https://forms.gle/j9Sc6VFJHxhhTZN6>**). For technical assistance, please contact the Examination Branch through the Telephone No. 065-2222663 during any working day from 9.00 a.m to 4.00 p.m.

After completion of online application procedure, the duly filled application form should be printed and signed by the Applicants. Further, candidates should submit all the Original documents as stated in Section 6 of application form along with printed and signed application form to **Deputy Registrar/ Examinations, Swamy Vipulananda Institute of Aesthetic Studies, Eastern University, Sri Lanka** on the day of Aptitude/Practical examination.

Instruction for Section 6 (1) for Application Form

Application should accompany with a paying-in-voucher as proof of payment made for **Rs.1000/-** for Bachelor of Fine Arts (Hons) in (Music / Dance / Drama & Theatre) and **Rs.1500/-** for Bachelor of Fine Arts (Hons) in Visual & Technological Arts as Examination fee obtained from any branch of the People's Bank drawn in favour of the **Deputy Bursar, Swami Vipulananda Institute of Aesthetic Studies, Eastern University, Sri Lanka, A/C. No. 075-100110000-767, People's Bank, Batticaloa Branch.**

Instruction for Section 6 (2) for Application Form

The certified copies of the G.C.E. (A/L) certificates should be attached along with the application. All copies of the certificates should be certified by the Principal of the School or Justice of Peace or Grama Niladhari. Original certificates should not be sent.

Instruction for Section 6 (3) for Application Form

If any discrepancy exists between the names indicated in the application and the names in the certificate/s, candidates should submit an affidavit attesting that they relate to one and the same person.

The date of the Examination would be informed by e-mail in writing to each candidate who has satisfied the admission requirements.

Please note that students who are not eligible for university admission but have applied for re-scrutiny of the G.C.E. (A/L) examination held in 2025, may apply for the Practical/Aptitude test upon submitting the required supporting documents.

The applications of those who do not possess the minimum admission requirements for the university admissions or applications which do not accompany with the paying-in-voucher or certified photo copies of certificates and applications received after the closing date will be rejected.
