All the certificates/documents should be certified as true copies by an authorized person and by the applicant as well.

examination, Postgraduate Diploma Certificate, other certificates relevant to recruitment qualifications.

- vi. Letter of confirmation constitutes that 1/3 of the content of the degree mentioned in paragraph 05 of this letter is available for the subject applied for.
- vii. Affidavit (as required) - If there are any differences in the names mentioned in the relevant educational certificates and other certificates/documents, an affidavit must be submitted in this regard.
- viii. Recently obtained Grama Niladhari Certificate (within 03 months)
- ix. Recently obtained certificate of good character (by a Justice of the Peace)

04. **Only for those applicants, who have verified that they have fulfilled the basic qualifications** for recruitment after checking the above documents and certificates during the general interview where the basic qualifications are scrutinized, are invited for the aptitude test interview. Therefore, all certificates/documents required to prove the basic qualifications as per your application in terms of the recruitment notification published in the Gazette No. 2,162 dated 07.02.2020 of the Democratic Socialist Republic of Sri Lanka and its amendments and certified photocopies must also be submitted to the interview board on that day and certificates/documents submitted later shall not be considered.

05. Detailed result documents of the relevant degree certificates must be submitted at the time of interview and certificates submitted later shall not be considered.

06. Certificates/documents that can be verified that the applied subject stream has been studied as a major subject for the degree and that at least one-third of the total number of subject units (credits) in the degree are subjects related to the subject applied for and a confirmation certificate issued by the Registrar of the relevant university to verify as such (As per the format of Annexure 01 published on the official website www.moe.gov.lk) should be submitted at the time of interview.

07. If the educational and professional qualifications mentioned in the notification are fulfilled based on certificates obtained from a foreign university, a letter issued by the University Grants Commission stating that the relevant university is an institution accredited by that Commission must also be submitted at the time of interview, and such letters submitted later will not be considered again whatsoever.

08. General qualifications stated under the serial i,ii,iii of Notification No. 04. I and the experience stated under No.04 III should be confirmed by Zonal Director of Education that the applicants have fulfilled the general qualifications by the due date. (As per the format of Annexure 02)

09. Applicants who have applied under the minimum qualifications should submit documents completed in Annexure 03 format to prove their teaching experience in the relevant subject area and teacher schedules certified by the Principal and Zonal Director of Education of the relevant schools. (As per Annexure 03 format)

10. All relevant qualifications must be completed before the closing date for applications.

11. Candidates should appear for the interview in the same medium of language in which they appeared for the written examination, however it is not essential that the relevant educational and professional qualifications have been obtained in the same medium of language as the one applied for .

12. Please be informed that since three times of the number of applicants are called for this interview than the number of vacancies, being called for this interview alone does not qualify you for a Grade III appointment in the Sri Lanka Teacher Educators' Service.
